I ALSO DO HEREBY WAIVE, RELEASE AND CANCEL ANY AND ALL CLAIMS WHICH I MAY OR HEREAFTER HAVE AGAINST EDGEWATER YACHT CLUB, OR ITS OFFICERS, TRUSTEES, RACE ADMINISTRATOR AND ANY COMMITTEE PERSONS WHICH DO OR DOES ARISE OUT OF MY PARTICIPATION OR UNDERTAKING TO PARTICIPATE IN THE CLEVELAND RACE WEEK, EXCEPT FOR ACTS WHICH ARE NOT RELATED TO OR NECESSARY FOR THIS EVENT. I will obtain and maintain appropriate liability insurance for damage or injury caused by my actions or negligence and, I have read and understand Fundamental RRS 4 as to my being responsible for deciding whether or not to start or to continue racing.

I have read and agree to be bound by the "Limited Waiver & Release" herein and acknowledge that this form must be signed, all fees paid and measurement certificates presented prior to the closing of registration in order to compete in the Cleveland Race Week.
